I.	<ul> <li>COMPLIANCE REQUIREMENTS</li> <li>The Generic Printer shall not discharge the following wastewater to the sanitary sewer:</li> <li>Untreated silver rich wastewater (fix, bleach-fix, washless stabilizer and low flow wash).</li> <li>Untreated wastewater generated from the production of copper or chromium plates.</li> <li>Wastewater containing solvents or mineral spirits exceeding local limits shall not be discharged.</li> </ul>
	The Generic Printer may choose pretreatment or off hauling for the wastewater. Pretreatment for silver rich wastewater shall be conducted in accordance with the Treatment Requirements in the <i>Guidelines for Film Processors/Printers</i> (enclosed). All wastewater discharges shall be in compliance with EBMUD Ordinance No. 311A-03.
II.	The Generic Printer shall not discharge any hazardous waste, as defined in Section 25117 of the Health and Safety Code, to the sanitary sewer.
III.	The Generic Printer shall provide EBMUD access to hazardous waste manifest records upon request.
IV.	The Generic Printer shall preclean plates, blankets, press fountains, and screens to remove inks prior to washing. The resulting wastewater shall be filtered to remove ink solids prior to discharge. The filtration shall be, at a minimum, a screen mesh placed over drains to capture ink solids. Wastewater containing solvents or mineral spirits exceeding local limits shall not be discharged.
I.	<b>REPORTING REQUIREMENTS</b> The Generic Printer shall report to EBMUD Environmental Services Division any changes, permanent or temporary, to the premises, processes or operations that significantly change the quality or volume of the wastewater discharge or deviate from the Terms and Conditions under which this Permit is granted.
II.	The Generic Printer shall notify EBMUD Environmental Services Division at (510) 287-1651 during business hours or toll free 1-866-403-2683 during non-business hours, immediately upon discovering any spill or slug discharge to the sanitary sewer. Formal written notification describing the circumstances and corrective actions shall be submitted to EBMUD within five working days of the occurrence.
<b>INSPECTIONS</b> EBMUD may conduct random, unannounced inspections to verify compliance with the conditions of this Permit.	
ENFORCEMENT AND PENALTIES EBMUD will pursue enforcement and penalties as authorized by Ordinance No. 311A-03, Title VI.	
AUTHORIZATION The General Printer is hereby authorized to discharge wastewater to the community sewer, subject to the General Printer's compliance with the EBMUD Wastewater Control Ordinance No. 311A-03, Permit Terms and Conditions, and billing conditions.
