COMPLIANCE REQUIREMENTS

- I. The Permit Holder shall not discharge any hazardous waste, as defined in Section 25117 of the Health and Safety Code, to the sanitary sewer. This prohibition includes any toxic solvents containing chlorinated compounds.
- II. Permit Holders discharging greater than 1,000 gallons per day shall use an oil and grease separator or an equivalent system in the washing area. The system shall treat the wastewater to comply with the EBMUD Ordinance No. 311A-03 discharge requirements. The Permit Holder shall follow the manufacturer's specifications and engineering guidelines regarding the operation and maintenance of the system.
- III. The Permit Holder shall display conspicuously in the vehicle washing area a sign(s) that prohibits facility users from discharging cleaning solvents containing chlorinated compounds.
- IV. The Permit Holder shall prohibit the use of self-service bays for the cleaning of automotive parts or components that are removed from the vehicle.
- V. The Permit Holder shall practice pollution prevention and water conservation measures to reduce or eliminate wastes released from the facility.

REPORTING REQUIREMENTS

The Permit Holder shall provide EBMUD, upon request, access to records or manifest of off-hauled facility sludge, oily waste, or hazardous wastes.

The Permit Holder shall provide EBMUD, upon request, access to technical specifications and engineering guidelines on the operation and maintenance of any oil and grease separator or equivalent system in place at the facility.

The Permit Holder shall report to EBMUD - Environmental Services Division any changes to the premises or operations that significantly deviate from the terms and conditions of this Permit.

The Permit Holder shall notify EBMUD - Environmental Services Division at (510) 287-1651 during business hours, or (866) 403-2683 during non-business hours, immediately upon discovering any spill or slug discharge to the sanitary sewer. Formal written notification describing the circumstances and corrective action must be submitted to the District within five working days of the occurrence.

INSPECTIONS

Compliance with the conditions of this Permit is verified through EBMUD inspections.

ENFORCEMENT AND PENALTIES

EBMUD will pursue enforcement and penalties as authorized by EBMUD Wastewater Control Ordinance No. 311A-03, Title VI.

AUTHORIZATION

The above named Permit Holder is hereby authorized to discharge wastewater to the community sewer, subject to said Permit Holder's compliance with the EBMUD Wastewater Control Ordinance, Permit Terms and Conditions, and billing conditions. EBMUD may amend this Permit to include revisions during the term of the Permit.
