- 1. Approve the Special and Regular Meeting Minutes of March 24, 2015.
- 2. File correspondence with the Board.
- 3. Award a contract to the lowest responsive/responsible bidder, Blocka Construction, Inc., in the amount of \$685,970 for construction of 82nd Avenue and Hollis Rate Control Stations Rehabilitation under Specification 2021.
- 4. Award a contract to the lowest responsive/responsible bidder, Clyde G. Steagall, Inc., in the amount of \$399,450 for construction of the Large Variable Frequency Drive Replacement Phase 1 Project under Specification SD 351.
- 5. Award a sole source contract to Kubota Corporation, in the estimated amount of \$152,600 to purchase earthquake resistant ductile iron pipe and appurtenances for a District pilot project.
- 6. Authorize an agreement beginning on or after April 15, 2015 with CH2M Hill Engineers, Inc. in an amount not to exceed \$125,000 to conduct a physical security vulnerability assessment for seven representative District water system facilities during the period of April 15, 2015 through November 30, 2015.
- 7. Authorize an amendment to an agreement with Garcia and Associates to increase the agreement value by \$130,000 to \$200,000 for specialized services in support of exhumation, repatriation and documentation for a Native American village site and burial area.
- 8. Authorize renewal of an agreement with Optrics, Inc. for one year beginning on or after April 21, 2015 in an amount not to exceed \$25,000 annually for spam and virus filtering with two options to renew for an additional one-year period for a total cost of \$75,000. The additional \$75,000 will increase the total costs for Optrics' services under the agreement to \$125,600.
- 9. Authorize agreements for bare equipment rentals:
 - 9a. Authorize an agreement beginning on or after April 15, 2015 with the following vendors: All American Rentals, Inc.; Ahern Equipment Rentals; Baker Corp.; Coast Crane Company; Doc Bailey Construction Equipment; NorCal Rental Group DBA Cresco Equipment Rental; Pape Machinery, Inc.; and United Rentals in an amount not to exceed \$1,610,000 annually, for bare equipment rentals for three years with two options to renew for an additional one-year period for a total cost of \$8,050,000.
 - 9b. Authorize additional agreements with companies that meet District standards and offer pricing at or below the range described in the current proposed contracts to increase flexibility and ensure vendor availability pursuant to this recommendation. Vendors will be rotated based on need, availability of the requested equipment, and cost of the specific equipment required. If additional vendors are added under this authorization, the Board of Directors will be notified by means of the monthly report to the General Manager.

 - 10b. Authorize additional agreements with companies that meet District standards and offer pricing at or below the range described in the current proposed contracts to increase flexibility and ensure vendor availability pursuant to this recommendation. Vendors will be rotated based on need, availability of the requested equipment, and cost of specific equipment required. If additional vendors are added under this authorization, the Board of Directors will be notified by means of the monthly report to the General Manager.

 - 16.2. Adopt a revised Section 28, "Water Use During Water Shortage Emergency Condition," of the EBMUD Regulations Governing Water Service to Customers. Section 28 defines and imposes temporary water use prohibitions and restrictions and enforcement provisions that will be effective April 14, 2015 and remain in effect until Section 28 is either revised based on changing circumstances or rescinded when the emergency is declared to be over. (Resolution)

Introduction and first reading of the new Excessive Water Use Penalty Ordinance For Drought Stages 3 and 4 ("the Ordinance") to provide the District with authority to impose administrative penalties on single-family residential customers who willfully use water in excess of the water use restrictions set forth in the Ordinance when the District has declared a Stage 3 or a Stage 4 water shortage/drought.
