

Debt Composition - Water




Total Outstanding as of June 30, 2014 \$2.6 Billion Total Outstanding as of June 30, 2015 \$2.7 Billion

<u>Highlights</u>

- District's first Green Bond sales
- Board's Green Bond Guidance was used to select qualifying projects which did not include projects that:
 - rely heavily on fossil fuel combustion or energy intensive;
 - generate large amounts of waste;
 - lack resilience to climate change; or
 - create unmitigated adversely impact the natural environment.



Issue \$25.5 million additional "new money" Wastewater Revenue Bonds

- Budget for FY16 and FY17 assumes \$25.5 million bonds issued
- Issuance expected at end FY16 or FY17 depending on cash flow

Butte Fire Current Status




- 70,868 acres burned
- 80% contained
- 2 fatalities



- 545 residences,
 356 outbuildings destroyed
- Started September 9, just north of District's Mokelumne Watershed

Butte Fire Mokelumne River Watershed





Butte Fire Mokelumne River Watershed






12,000 acres burned in Mokelumne watershed (3% of watershed)

Butte Fire Immediate Impacts



Staff Directly Impacted

- 3 Employees Lost Homes
- 13 Employees Evacuated/Displaced



Butte Fire Immediate Impacts



Community Impacts

- Devastating impacts in Calaveras County, homes, power, phones, water and wastewater systems
- Far less significant impacts in Amador County, mostly normal operations for AWA

Butte Fire EBMUD Response Actions



- Regular check-in with water agencies, no aid requested yet
- Opened up Camanche South Shore campground to displaced residents
- Housing some employees at Pardee Center
- Through CALWARN offered mutual aid to Calaveras OES (no request as of this time)
- Attending community meetings hosted by CalFire
- Meeting with Bureau of Land Management today to coordinate on protection actions



- Water Quality
- Sedimentation in river and Pardee
- Debris

Butte Fire Upcoming Response Actions



- Survey burned area
- Identify highest priorities for actions
- Work with landowners, public and private, to implement measures
- Implement water quality monitoring program





- 76,000 acres burned (75% contained)
- 1910 structures destroyed
- Started September 12
- In response to California OES, EBMUD has responded to assist with damage inspections and may assist with recovery actions for water/wastewater systems
