California's Department of Industrial Relations (DIR) Registration & Reporting Requirements

The DIR now requires vendors/contractors providing public works services to East Bay Municipal Utility District (EBMUD) to be registered with DIR before bidding on any public works projects. Vendors/contractors cannot be issued work without us first confirming they are registered. EBMUD must report subject purchase orders to the state within five (5) working days. This applies to all public works projects over \$1,000 where prevailing wage is required.

"Public Works" is defined in the Labor Code to include but not be limited to work performed under contract (e.g. not by our own forces) and paid for in whole or in part out of public funds:

- construction
- alteration
- demolition
- installation
- repair work

- maintenance
- carpet laying
- hauling (sometimes)
- · inspection, and
- land surveying work

Note: By statute, "construction" includes work performed during the design and preconstruction phases of construction, including, but not limited to, inspection and land surveying work.

Prevailing wage is required for public works projects and vendors/contractors must submit certified payrolls to the state for these projects. All bidders are required to pay the applicable prevailing wage rates or higher to their workers on a public works project.

If you provide quotes/bids over \$1,000 for a public works project, for EBMUD or other public agencies, please make sure you are registered with DIR and include your DIR registration number on the quote/bid. Currently the fee to register with DIR is \$300 annually. EBMUD will verify all vendors/contractors are registered prior to issuing any purchase orders and will complete the required state notification.
