EBMUD filed the WSMP 2040 draft Program Environmental Impact Report (PEIR) with the State Clearinghouse on February 19, 2009. A series of public meetings are scheduled from March 16 to March 23. The comment period closes on April 6, 2009 and the Final PEIR is scheduled to be published in June 2009.

We hope to see you at our last CLC meeting on March 10, 2009. At the meeting, we will discuss the findings of the draft PEIR, the analysis of the Preferred and Alternative Portfolios, and the key messages of the WSMP 2040 Plan.

Recap of the June 24, 2008 EBMUD Board of Directors meeting regarding the Preferred Portfolio:

- The Board preferred a rationing level of 10%.
- The Board agreed on Conservation Level D (39 MGD) and Recycling Level 3 (11 MGD).
- The Board agreed to exclude Buckhorn Reservoir from the Preferred Portfolio.
- Several supplemental supply components remain in consideration to meet the need-for-water (that is not met through rationing, conservation and recycling). It was noted that supplemental supply projects would be pursued on parallel tracks in the event that one (or more projects) are not able to produce the expected dry-year yield. The projects include:
 - Water Transfers (to meet the initial need-for-water);
 - Bayside Phase II Groundwater Project;
 - Sacramento Basin Groundwater Project;
 - Regional Desalination; and
 - Regional upcountry projects, including enlarging Pardee Reservoir, raising Lower Bear Reservoir and IRCUP/San Joaquin Groundwater Banking.
