WaterSmart Businesses Commended

BMUD recognized seven businesses and institutions for outstanding water-use efficiency in 2010. Together these EBMUD customers reduced their annual water use by more than 69 million gallons in 2009—that's enough water to serve about 650 households for an entire year. Saving water also improves the businesses' bottom line, slashing thousands of dollars of costs.

2010 WaterSmart Business certificates were awarded to five facilities run by public agencies, so their communities benefit from the savings. Castro Valley Sanitary District made indoor and outdoor changes and reduced water use 82 percent annually. The City of El Cerrito installed high-efficiency plumbing fixtures at City Hall and established a water budget tailored to the needs of the landscape in the San Pablo Avenue median, more than halving the water

used in these two areas. The City of Hercules planted drought tolerant, native plants and installed a central irrigation control system for Frog Pad Park and John Muir Parkway. The City of San Leandro



Businesses implementing water-efficient best practices receive a certificate that can be publicly displayed for three years. installed low-water-use landscaping and stormwater retention basins to control runoff in the Senior Center Car Park. And the Social Security Administration upgraded plumbing fixtures, installed low-water

use landscaping, and developed an employee water efficiency education program at the Frank Hagel Federal Building in Richmond.

Blackhawk Homeowners Association changed out old landscaping with new, low-water-use plants. Captain Vineyards in Moraga installed dry-farming drip irrigation and cut water use 60 percent. Congratulations to the East Bay's 2010 WaterSmart Certificate recipients!

ost of us know that leftover liquid cleaners and other liquid products don't go in the trash. If the label says poison, corrosive, toxic, ignitable or reactive, then it's a household hazardous waste. That means it's unsafe for landfills,

because such wastes can cause gas build-ups that start fires or can leach out of landfills into water sources.


Some people think diluting these types of liquids by pouring them down the kitchen sink is a solution. But remember, what goes down your sink goes to the sewer and ultimately to San Francisco Bay. Even in small

amounts, some of the chemicals in household hazardous wastes can interfere with the environmentally safe and effective microorganisms that break down and eliminate waste products at EBMUD's wastewater treatment plant and protect San Francisco Bay.

Before you reach for the faucet, read your household product label. Leftover oil-based paints and stains, cleaners, oils and pesticides contain potentially hazardous ingredients and should never be poured down a sink! Help keep San Francisco Bay clean and take those unwanted household chemicals to a household hazardous waste disposal facility.

Alternatives are available for most household uses that do their job effectively while being gentler on the environment. Look for water-based paint and stain products instead of solvent-based or oil-based ones. Avoid cleaning products containing chlorinated compounds, petroleum distillates, phenols and formaldehyde.
