PUBLIC HEARING

10.1. Conduct a public hearing to consider objections and protests to EBMUD's written report describing each parcel of real property subject to the Wet Weather Facilities Charge (WWFC) and amount of the WWFC to be imposed on each parcel for the counties' Fiscal Year (FY) 2022-2023 Property Tax Rolls.

President Linney opened the public hearing at 1:53 p.m. He announced the hearing is to consider objections and protests to EBMUD's written report describing each parcel of real property subject to the WWFC and amount of the charge to be imposed on each parcel for the Alameda and Contra Costa counties' 2022-2023 Property Tax Rolls.

Manager of Wastewater Engineering Douglas Y. Higashi provided the presentation which included an overview of the District's wastewater collection system and treatment processes and explained the WWFC funds capital expenses for the District's inflow and infiltration facilities (including wet weather facilities, interceptors, pumping stations and storage basins). For 2022-2023, the WWFC totals approximately \$30.7 million and represents 20 percent of total revenue for the Wastewater System. Mr. Higashi reviewed the procedural requirements in the State's Health and Safety Code (H&SC) that authorize the District to collect the WWFC on the counties' property tax rolls. In compliance with H&SC section 5473, staff filed a report with the Secretary of the District on June 9, 2022 that contains the parcel number and amount of the charge for each parcel. Mr. Higashi discussed how the WWFC is structured into three generalized lot sizes (or bins) and said for FY 2022-2023, the amount charged by lot size is: \$125.16 for lots of 0 to 5,000 square feet (sq. ft.); \$195.50 for lots 5,001 to 10,000 sq. ft. (the report filed with the Secretary on June 9, 2022 listed \$195.60); and \$446.80 for lots over 10,000 sq. ft. In accordance with California Government Code section 6066, the District published notices of the public hearing in the Oakland Tribune and West County Times on June 17 and June 24. Mr. Higashi said staff is recommending the Board consider approving the actions outlined in agenda Items 10.2a-10.2d. If approved (by two-thirds of the members of the Board as outlined in the H&SC), the Secretary of the District will file a copy of the report with the auditors of Alameda and Contra Costa counties on or before August 10. President Linney called for Board questions. Director of Finance Sophia D. Skoda responded to questions on whether the District will cease collecting the WWFC once the District meets all conditions under the U.S. Environmental Protection Agency Wet Weather Consent Decree. Next, President Linney called for public comment. There was no public comment. President Linney announced the District did not receive any protests to the written report, asked for a motion to close the public hearing, and closed the public hearing at 2:03 p.m.

DETERMINATION AND DISCUSSION

11. Legislative Update.

Special Assistant Debra L. Michel provided an overview of two bills for Board consideration in Legislative Report No. 05-22. A prior version of SB 222 (Dodd) Water Rate Assistance Program (Program) was considered by the Board on July 13, 2021. At that time, the Board adopted a "Support if Amended" position with amendments to clarify that the obligations of the water system's role in the Program are limited to applying program funds to eligible lowincome customer accounts and to address Proposition 218 concerns. Amendments were secured and reflected in the August 30, 2021 version of the bill and EBMUD moved to a full "Support" position. The bill was substantially amended on June 23, 2022 and recast in such a manner that EBMUD's concerns are no longer addressed. Staff is recommending a change in position back to "Support if Amended." SB 1063 (Skinner) Energy: Appliance Standards and Cost-effective Measures as amended on June 20, 2022, would authorize the Energy Commission to make energy- and water-efficiency standards for appliances effective sooner than one year after adoption or revision if the Energy Commission adopts a finding of good cause. Staff is recommending a position of "Support." Legislative/Human Resources Committee member John A. Coleman reported the Committee met earlier and supported the staff recommendations for both bills. There was discussion regarding the requested amendments and staff recommendation for SB 222. The Board asked staff to convey its concern regarding the August 30, 2021 amendments to SB 222 and potential issues with Propositions 218 and 26.

Next, Ms. Michel provide an update on the state budget and reported Congresswoman Barbara Lee is advancing a \$4.2 million funding request on behalf of the District for a water recycling project that would tie into the District's East Bayshore Recycled Water Project.

General Manager Clifford C. Chan reported the number of COVID-19 positive cases in the service area remain high and provided an update on the number of District employee positive cases to date. The Board is being asked to adopt the resolution to continue providing flexibility for conducting Board meetings in light of the uptick in positive cases.

He reported on plans to attend the Los Vaqueros Reservoir JPA Board meeting on July 13 (remote); Los Vaqueros Reservoir JPA Finance Committee meeting on July 28 (remote) and Los Vaqueros Reservoir JPA Board meeting on August 10 (remote). Director Coleman acknowledged Community Affairs Representative Kathryn Horn for assisting with the presentation to the Pleasant Hill City Council and commented on the Watch Duty app which provides real-time push notifications about wildfires in California.
- Director Young reported John Silva with Give Back Adventures completed the Mokelumne River Source to the Sea Multi-Sport Expedition two weeks ago and announced that on June 30, Nina Gordon-Kirsch began a 240-mile walk from her home in Oakland to the headwaters of the Mokelumne River. Director Young asked staff to provide the hyperlinks to Gordon-Kirsch's website and social media pages to Board members and to have District staff make contact with Gordon-Kirsch for a potential tour of the Mokelumne River Fish Hatchery. She also asked staff to reach out to Silva and Gordon-Kirsch to explore ideas on how the District can share their journeys with customers.
