  - 9.1. Award a contract to the lowest responsive/responsible bidder, Flatiron West, Inc., in an amount not to exceed \$237,332,710 for construction of the USL WTP Maintenance and Reliability and USL and Sobrante WTPs Chemical Systems Safety Improvements projects (CSSIP), under Specification 2128.
  - 9.2. Award a sole-source contract to Honeywell International Inc. for purchase of two remote input/output control system cabinets and associated hardware for the temporary chemical systems at the USL and Sobrante WTPs, for a total cost, after the addition of taxes, not to exceed \$175,000.
  - 9.3. Authorize an agreement beginning on or after February 14, 2023, with Stantec Consulting Services, Inc. in an amount not to exceed \$8,263,665 for ESDC for the USL and Sobrante WTPs CSSIP and for as-needed chemical system improvements design services and ESDC for other raw water treatment facilities.
  - 9.4. Authorize an agreement beginning on or after February 14, 2023, with Jacobs Associates, Inc. dba Delve Underground in an amount not to exceed \$427,724 for specialized shoring ESDC for the USL WTP Maintenance and Reliability Project under Specification 2128.
