### SUMMARY

In accordance with Policy 4.07 – Investment Policy, staff prepares a monthly transactions report for the Finance/Administration Committee to review and for the Board to consider each month. The October 2021 report is being submitted to the Board for consideration. This report will be presented at the November 23, 2021 Finance/Administration Committee meeting.

### DISCUSSION

Pursuant to Policy 4.07, staff prepares a monthly report of investment transactions (buys, sales, deposits, withdrawals) as well as transactions that occur as a feature of the securities held (interest, calls, maturities). Information on portfolio performance, balances, and other factors is presented in the quarterly investment report.

In October 2021, the portfolio increased from \$764.9 million to \$772.1 million. Net transactions increased the total by \$7.0 million. Interest received added approximately \$0.2 million to the portfolio. Deposits into short-term liquidity funds totaled \$13.3 million, and \$41.4 million was withdrawn. The District purchased \$110.0 million in securities, and \$42.8 million in securities matured. No securities were called or sold. Net transactions at the District's commercial bank resulted in a decrease of \$32.1 million.

### **NEXT STEPS**

This item will be brought to the Board for consideration at its meeting on November 23, 2021.

### SUMMARY

In accordance with California Government Code Section 53065.5, staff prepared the Listing of Employee Reimbursements of at least \$100 for the fiscal year ending June 30, 2021. The listing also includes reimbursements for the Board of Directors. Reimbursements for the period July 1, 2020 through June 30, 2021 totaled \$106,399.41. This item will be discussed at the November 23, 2021 Finance/Administration Committee meeting.

### **DISCUSSION**

Section 53065.5 of the California Government Code requires special districts, as defined by subdivision (a) of Section 56036, to at least annually, disclose any reimbursement paid by the special district within the immediately preceding fiscal year of at least \$100 for each individual charge for services or products received. "Individual charges" include, but are not limited to, one meal, lodging for one day, transportation, or a registration fee paid to any employee or member of the governing body of the special district. The disclosure requirement shall be fulfilled by including the reimbursement information in a document published or printed at least annually by a date determined by that district and shall be made available for public inspection.

### SUMMARY

During the February 9, 2021 Customer Assistance Program (CAP) Workshop, staff shared with the Board a plan to promote and increase CAP participation. Since the beginning of the COVID-19 pandemic, CAP enrollment has increased over 30 percent. As discussed at the CAP Workshop, to support the increased participation additional sources of non-rate revenue is needed. In addition, staff is securing COVID-19 relief funds through the Emergency Rental Assistance Program (ERAP) and the California Water and Wastewater Arrearage Payment Program (CWWAPP). These items will be presented at the November 23, 2021 Finance/Administration Committee meeting.

### DISCUSSION

The District is actively working to secure COVID-19 relief funds through the ERAP and the CWWAPP to support customers affected by the pandemic, especially households in disadvantaged communities. The District is seeking approximately \$12 million which will help approximately 11,000 households and businesses. Securing COVID-19 relief funds remains a top priority. These COVID-19 relief funds are one-time emergency programs and do not have ongoing funding.

Even before the COVID-19 pandemic, the District promoted its CAP to increase participation for eligible households. To support the growth, the District is proactively exploring opportunities to increase non-rate revenue to fund its CAP. It costs approximately \$336,000 (Fiscal Year 2021 (FY21) dollars) in non-rate revenue to fund every 1,000 new CAP participants. With current CAP participation at more than 9,200 households, the annual cost to fund the program is estimated at over \$3 million in FY22. If CAP participation reaches the projected 33,000 households, the annual cost to fund the program would be approximately \$10 million (FY21 dollars). The following are options to secure a sustainable source of non-rate revenue to support the CAP.

### Real Estate Revenue

Real estate leases provide the District a significant and reliable source of non-rate revenue. In FY21, the District generated over \$4.9 million in non-rate revenue from underutilized real estate properties. Nearly \$2 million were generated from 22 non-telecom land leases. Most of these land

leases are for five years or less with renewal terms at the discretion of the District. The District is actively working with potential tenants at several other underutilized properties to expand this lease portfolio.

In addition to the land leases, the District has 41 telecom leases at 26 properties that generated approximately \$2.9 million in FY21. These telecom leases were entered into by staff pursuant to Board Resolution No. 33001-96 ("Delegation Resolution"). The Delegation Resolution (1) requires completion of any necessary California Environmental Quality Act (CEQA) review and issuance of building approvals prior to lease execution, and (2) authorizes staff to enter into one-year lease options with potential lessees to allow for completion of the local planning and building approval process. The Delegation Resolution was intended to expand telecom lease opportunities.

Telecom operators have recently found the District's process impractical because the District is unable to enter into a direct lease. Without an executed lease, the lessee would risk the District electing to not move forward with a lease agreement after all local planning and building approvals are secured by the telecom operator. Since telecom sites are interdependent, the possibility of losing any site within the network could have broad impacts for the operator. Furthermore, telecom operators find the one-year lease options authorized under the Delegation Resolution insufficient, as the permitting process has become more complex since the 1990s when this resolution was adopted. As a result, potential lessees that have expressed interest at 12 District sites, with an annual estimated combined lease amount of \$600,000, have withdrawn their letter of interest.

**Recommendation:** Update the Delegation Resolution to authorize staff to enter into leases with the telecom operators for District sites that are CEQA exempt with minimum community impacts but require the lessee to obtain all approval from jurisdictions with project oversight for the lease to become effective and allow for site control. For sites that require CEQA review, the District will continue to require completion of any necessary review and for the lessees to obtain all building permit approvals prior to lease execution.

### Unclaimed Funds as Balances on Closed Accounts

There is approximately \$2.1 million in unclaimed funds from customers who cannot be located after accounts are closed and numerous attempts have failed to locate the account holders to return the funds. Government Code Section 50050 authorizes the District to transfer amounts from closed accounts with balances less than \$15 after one year to the general fund. Closed accounts with balances greater than \$15 and older than three years can be transferred to the general fund after a notice is published in a newspaper of general circulation for two consecutive weeks. If the funds are not claimed within 45 days after the publication, the District can claim the funds. Of the \$2.1 million in unclaimed funds, approximately \$27,000 is from closed accounts with balances less than \$15, and over \$1.4 million could be transferable upon completion of the public notification and claim process. The remaining balance of unclaimed funds is greater than \$15 per account and less than three years old, therefore, the notification for the transfer to general fund cannot be initiated.

Since the April 27, 2021 Finance/Administration Committee meeting, staff updated Section 13: Payments of Bills, of the District's regulations to codify the approach to manage unclaimed funds. Furthermore, Procedure 102 - Billing Allowances and Revenue Adjustments was revised to provide guidance on refunding closed accounts in pursuit of this effort. An additional procedure has been drafted to include a process for immediately closing accounts and issuing refunds, and earmarking the future unclaimed funds for CAP. This will prevent the accumulation of large sums of unclaimed funds going forward.

**Recommendation:** Transfer \$27,000 in unclaimed funds immediately to support FY22 CAP activities and begin the public notification process for the approximately \$1.4 million in remaining unclaimed funds by customers with closed accounts.

### **Customer Donations**

At the April 27, 2021 Finance/Administration Committee meeting, staff discussed an option to allow customers to "round up" their online bill payment to a desired amount, or process a separate transaction independent of the water bill as a donation towards CAP. After further review, collecting voluntary donations could be subject to state laws regulating charitable organizations. Generally, state law requires a legal entity to register their organization with the California Attorney General if the legal entity intends to solicit funds for a charitable purpose. To collect customer donations, the District would need to create a separate trust to hold the donations to ensure the funds are used only for the purpose of CAP. To satisfy these requirements, the District would need to dedicate staff resources to administer the donation program, which would reduce the financial benefit for CAP customers.

**Recommendation:** Instead of creating a separate donation program, the District can work with the Water Lifeline partners to expand their program's capabilities. This alternative could include the creation of a separate secure portal for the agencies to verify delinquencies along with modifications to the District online bill payment webpage where customers can "round up" their online bill payment to a desired amount, or process a separate transaction independent of the water bill as a donation to provide financial assistance to District customers. Under this arrangement, the donated funds would be transferred directly to the District's partner charities for the management and disbursement of these donations to eligible customers. Since these donations are received by charities supporting the Water Lifeline, they will be tax-deductible which would be an added incentive for potential donors.

### Private Lateral Insurance

Utilities around the country have partnered with private water service line plan providers to offer customers the option to purchase water service line repair plans to offset costs related to private service line repairs. This type of partnership could be a source of non-rate revenue to support CAP. Based on the number of District customer accounts, staff estimates this potential source of revenue could range from \$140,000 to \$500,000 annually. Additionally, one provider will offer financial incentives up to \$50,000 annually to support low-income assistance programs. Aside from revenue considerations, other utilities have used these partnerships to educate customers about their responsibility for leak repairs.

One drawback of such a partnership would be potential customer confusion since customers would see the District logo on the providers' marketing materials and incorrectly conclude the plans are offered by the District. The customer confusion may also increase District liability if customers pursue claims against both the provider and the District. However, the risk of financial exposure resulting from claims against the District could be eliminated or limited based on negotiated terms with the provider.

**Recommendation:** Continue to assess the long-term benefits of a private lateral insurance program.

### NEXT STEPS

The District has limited opportunities to develop a sustainable source of non-rate revenue to support the growing customer assistance program. In consideration of the available opportunities as identified, staff recommends pursuing real estate leases as its first priority since it is the most viable and sustainable option and has the potential to fully fund CAP. The District will also pursue collection of unclaimed funds and customer donations. Based on Committee feedback, staff will bring a CAP funding strategy for Board consideration during the 2022 CAP Workshop and execute the long-term funding strategy for CAP according to priorities set forth by the Board.
