SUBJECT:	Miller Road Trench Soil Management Project – Update on Outreach and Comments Received on the Draft Mitigated Negative Declaration

SUMMARY

The Miller Road trench soil stockpile site is located within District-owned watershed land southeast of the Upper San Leandro Reservoir near Castro Valley in unincorporated Alameda County. Since 1975, the District has used the site to store excavated material generated by pipeline construction and maintenance activities. In 2023, Alameda County communicated to the District that continued use of the site would require a Conditional Use Permit (CUP) supported by appropriate California Environmental Quality Act (CEQA) review to assess the potential environmental impacts.

In consultation with the county, a Draft Initial Study/Mitigated Negative Declaration (IS/MND) for the Miller Road Trench Soil Management Project was released on March 20, 2025. The IS/MND was distributed to responsible agencies by mail and made available on the District's project website: <u>www.ebmud.com/MillerRoad</u>. The deadline for public comment was extended from April 21, 2025 to May 19, 2025 in response to feedback from the community.

DISCUSSION

The District received written comments on the Draft IS/MND from the following groups:

- Members of the public (three individuals)
- California Department of Fish and Wildlife
- Castro Valley Municipal Advisory Council
- Alameda County Department of Transportation
- Alameda County Planning Department

NEXT STEPS

Staff will prepare responses to all comments received during the public review period and incorporate responses into the Final IS/MND, which is scheduled for Board consideration on August 12, 2025. If the Board certifies the Final IS/MND, staff will proceed with submitting a CUP application to Alameda County. The next off-haul event from the Miller Road stockpile site is anticipated in 2026, with additional public outreach and coordination with Alameda County and the local community to be conducted in advance.
