SUBJECT: Follow-up on Regulatory Compliance

SUMMARY

In response to a request from the Planning Committee at its August 12, 2025 meeting, this memorandum provides additional information on the facilities where the District is pursuing Green Business certification and past regulatory violations at the Oakport Wet Weather Facility (WWF).

DISCUSSION

The California Green Business Program is a network of local programs operated by counties and cities throughout the state. The District has participated in the program since 2007. There are currently twelve District facilities that have been certified after implementing practices to reduce waste, save water, conserve energy, and protect the environment. Certifications are renewed every four years. The list of certified facilities includes:

- Adeline Maintenance Center Administration Building (Oakland)
- Adeline Maintenance Center Fleet (Oakland)
- Adeline Maintenance Center Print Shop (Oakland)
- Castenada Service Center (San Ramon)
- East Area Service Center (Walnut Creek)
- Lafayette Recreation Area Visitor Center (Lafayette)
- Lafayette Water Treatment Plant (Lafayette)
- Main Administration Building (Oakland)
- Materials Testing Laboratory (Oakland)
- North Area Service Center (Richmond)
- Sobrante Water Treatment Plant (El Sobrante)
- Walnut Creek Water Treatment Plant (Walnut Creek)

Staff is currently pursuing certifications for the South Area Service Center (San Lorenzo), the Upper San Leandro Water Treatment Plant (Oakland), and the Mokelumne Headquarters (Valley Springs). Certification can take several months depending on necessary capital upgrades.

National Pollution Discharge Elimination System (NPDES) permit requirements at the Oakport WWF are supplemented by the 2014 Consent Decree (Consolidated Case Nos. C 09-00186-RS and C 09-05684-RS). Collectively, these are the primary regulatory permits for this facility. The last ten years of NPDES compliance history for the facility is summarized below.
