ORINDA WATER TREATMENT PLANT LIFT STATION ELECTRICAL MAINTENANCE IMPROVEMENTS (ESR 25-778-001)

Overview and Background

The East Bay Municipal Utility District owns and operates Orinda Water Treatment Plant (WTP) as part of its system that provides customers with safe drinking water that meets or exceeds all regulatory standards. The Orinda Lift Station is required to regularly pump waste effluent from the treatment process to the settling ponds located across the main WTP site. The electrical maintenance improvements will ensure that the lift station pumps operate on a more reliable power distribution and motor protection system, which greatly reduces the risk of electrical failures of this system.

Purpose and Objectives

The Orinda WTP was constructed in 1935 and has been regularly upgraded over several decades. The lift station was added to the treatment system in the 1980's and currently requires electrical maintenance improvements to ensure reliable operation of the lift station pumps.

Project Characteristics

The Project consists of installing a 24-foot by 10-foot concrete pad with conduits, electrical equipment, and a canopy, as well repaving of the lift station area.

Permits and Approvals

No permits are required for the Project because all work will be performed on EBMUD's Orinda WTP property.

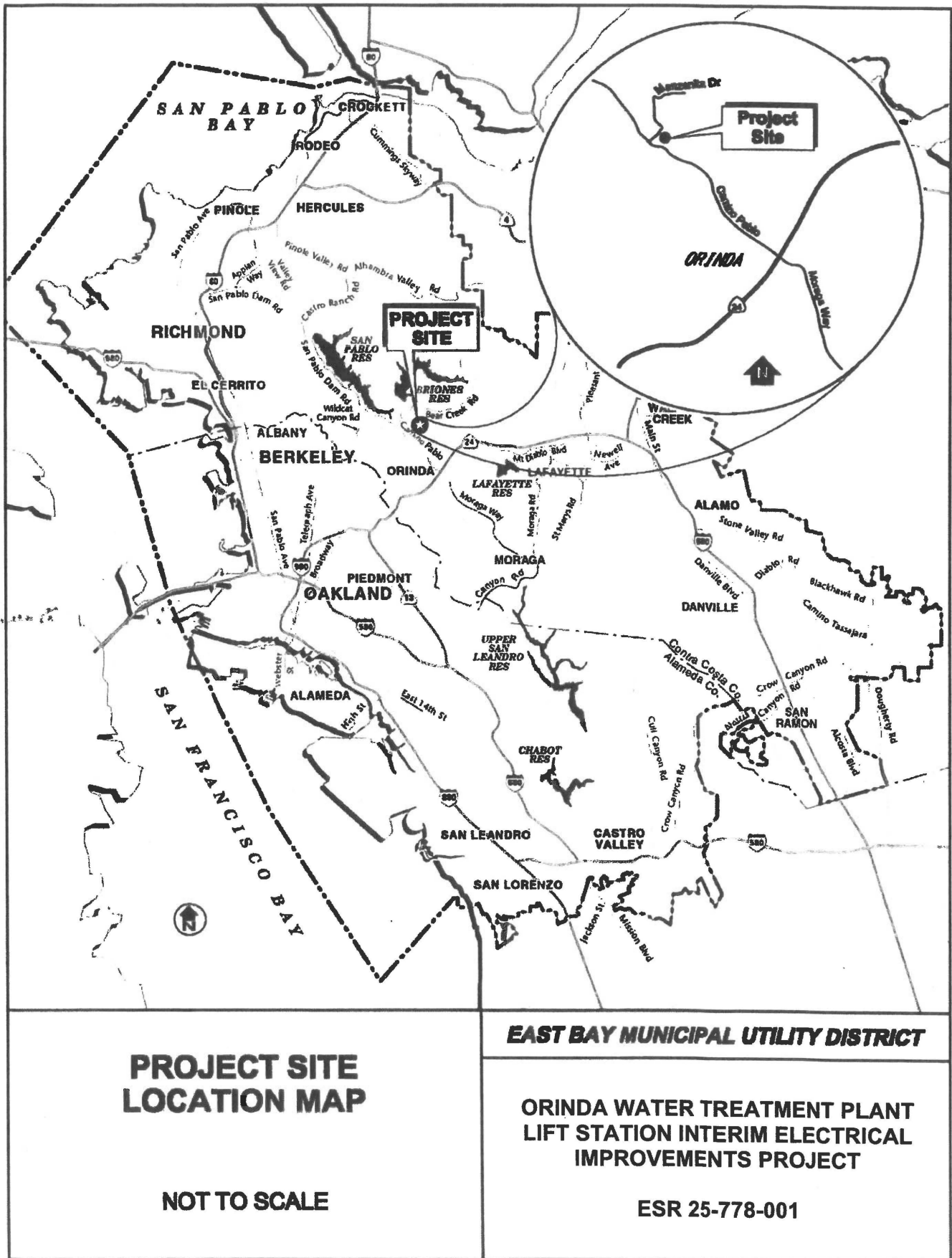
Schedule and Work Hours

Construction is scheduled to occur within the span of 2025-2027. Regular work hours will be from 8 A.M. to 6 P.M., Monday to Friday.

EBMUD Practices and Procedures

Standard construction environmental and safety practices applicable to all EBMUD construction projects have been incorporated into the Project. These standard practices minimize impacts to the public resulting from EBMUD construction projects.
