

## California's New Climate Laws: Why Small Businesses Need an Environmental, Social, and Governance (ESG) Strategy Now

### Why ESG Matters for Small or Medium-Sized Businesses (SMBs)

If you run an SMB, it might be tempting to view ESG concerns as something reserved for large enterprises. But here's the truth: ESG principles are becoming essential for organizations of all sizes. Customers, suppliers, and community partners increasingly expect companies to demonstrate responsible practices, transparent operations, and measurable contributions to environmental and social well-being.

For instance, new California state laws—SB 253 and SB 261—require large companies to publicly disclose greenhouse gas emissions and climate-related financial risks beginning in 2026. While these laws directly apply to businesses with revenues over \$500 million, small and medium-sized businesses in their supply chains will increasingly be asked to provide emissions data to help larger partners meet compliance requirements. ## Key ESG Concepts Every SMB Needs to Know

Understanding the basics of ESG makes it easier to determine where to begin.

- 1. Carbon Footprint:** The total greenhouse gas emissions generated by your business activities, including energy use (electricity, heating, cooling), transportation, the production of goods or services, and waste.
- 2. Net Zero:** A goal to balance the amount of greenhouse gases your company emits with the amount it removes or offsets.
- 3. Sustainability:** Practices that conserve resources and reduce environmental impact, such as recycling, energy-efficient equipment, or water conservation.
- 4. Social Impact:** How your company affects employees, customers, and the broader community, including fair labor practices, inclusive hiring, and community engagement.
- 5. Governance:** Policies and processes that guide how your business operates internally, including leadership ethics, financial reporting, compliance with laws, and transparency with stakeholders.

## How to Get Started

You don't need a large budget or team to take meaningful ESG action. Begin with a simple baseline: review how your business uses energy and water, how waste is managed, and how you support employees and customers. Identify areas to improve and set realistic goals for the next 6–12 months. Small steps such as switching to LED lighting, reducing paper use, or tracking workforce metrics, can make a measurable difference.

Communicate your progress. Share updates on your website, in proposals, and with partners evaluating suppliers for responsible practices. Clear communication reinforces credibility and helps stakeholders understand the value you bring.

## The Bottom Line for SMBs

By understanding key ESG concepts, you can position your business not only to meet today's expectations but also to thrive as values-driven decision-making becomes the standard. No matter where you are in your ESG journey, the most important step is the first one. Start small, stay consistent, and remember that the path toward ESG alignment is ultimately about building a stronger, more resilient business for the years ahead.
