

Commercial Clothes Washer Rebate Application

Program Overview and Eligibility

The East Bay Municipal Utility District's (EBMUD) WaterSmart Commercial Clothes Washer Rebate Program (Program) pays rebates for the installation of new water and energy-efficient commercial clothes washers in multi-family and institutional common area laundry facilities, businesses with on-premise laundry, and coin laundry stores (e.g. Laundromats). To be eligible, such facilities must receive water service from EBMUD and meet all other program requirements set forth in this Application.

Rebate Amounts

- Coin laundry stores: \$125.00
- All other facilities: \$75.00

Qualifying Products

Any of the machines listed on the EBMUD-approved list of qualifying commercial clothes washers or any machine with a water factor (number of gallons needed for each cubic foot of laundry) no greater than 4.1.

How to Apply

Submit a separate EBMUD application for each property or business where qualified machine(s) are installed.

Please complete the following:

Read the application and product requirements carefully to verify that you are eligible (see reverse side).

- Email WaterConservation@ebmud.com to ensure that the machine(s) you are planning to purchase qualifies for a rebate and for any other program related questions.
- Purchase or lease (minimum 5-yr term) qualifying clothes washing machine(s).
- Install qualifying machine in facility serviced by EBMUD.
- Complete the rebate application (Please see limitations*).
- Attach copies of receipts or lease agreements.
- Remember to sign and date the Application Agreement clause on the application.

- Application must be postmarked within 90 days of purchase or lease of qualifying machine.

Rebate is issued as a check payable to the account holder and mailed to the billing address on file within two months of rebate approval. To request an alternate payee, submit a [Payee Change Request Form](#) for EBMUD approval.

I have read and understand the Program requirements set forth in this application and agree to abide by these requirements. I understand that rebate payment is contingent upon the verification of application information. I assert that I intend to use all the clothes washers described above for a minimum of five years at my facility and not to resell them before the end of the five-year period. If the machines are not used for the full five-year period, I understand that I may be required to refund a prorated share of the rebate to EBMUD based on the number of months left in the five-year period.

I understand that the qualifying commercial clothes washer must be new and purchased or leased on or after the Program start date of January 1, 2026, thru December 31, 2026. I certify that the commercial clothes washer(s) have been installed and are eligible according to the specifications presented in this application. I agree to allow EBMUD inspectors to verify application information and access the facility with reasonable advance notice, should an on-site inspection be required by the Program.

I understand that the Program's rebates are a limited offer and are contingent upon availability of funding and that rebates will be distributed on a first-come, first-served basis, until funds run out or the program terminates, whichever occurs first.

I understand there is a limit of one (1) rebate per clothes washer within a five (5) year period.

I agree that the selection, purchase, lease or ownership of commercial clothes washers is my sole responsibility. EBMUD makes no representation as to the safety, reliability and/or efficiency of the clothes washers selected or components thereof, and makes no warranty whether expressed or implied, including warranty of merchantability or fitness for any particular purpose.

Machines must have been purchased or lease agreements signed on or after January 1, 2026 through December 31, 2026 to be eligible for the program.

If the total rebate amounts received are \$2,000 or more in a single calendar year, a 1099 form will be issued in accordance with Federal Internal Revenue Service requirements. Most rebates are excluded from gross income by state law and are not subject to state income tax, but these rebates may be taxable income under federal law. The determination of whether the rebate may be subject to federal or state tax is dependent on several variables, and it is recommended that you contact a tax professional for further information.
