#### SUMMARY

On June 22, 2021 the Redistricting Ad Hoc Committee met to discuss guidelines for the District's 2021-2022 redistricting efforts. The Committee reviewed the guidelines and criteria used in 2011-2012 and provisions from the FAIR MAPS Act (AB 849 – Bonta). Based on questions and feedback from the Committee, staff prepared draft redistricting guidelines and additional information regarding the redistricting process. This information will be discussed at the August 24, 2021 Redistricting Ad Hoc Committee meeting.

#### DISCUSSION

At its June 22, 2021 meeting, the Committee directed staff to draft redistricting guidelines that reference points in the FAIR MAPS Act that were not in the 2011-2012 guidelines and to address the following:

- If the public can use the District's redistricting software to prepare draft ward boundary maps
- Information on why special districts were not included in provisions of the FAIR MAPS Act
- Accessibility for all Board meetings (e.g., real-time translation, real-time interpreters, closed-captioning, materials translated into the common languages spoken in the service area) including livestreamed redistricting meetings
- If the Board is required to hold public hearings for redistricting and if virtual meetings count as public meetings for the purposes of redistricting
- Including a redistricting tab or hyperlink on the District's homepage

#### Draft Redistricting Guidelines

Staff prepared the draft guidelines (attached) based on direction from the Committee. The guidelines include information on how the Board will, to the extent possible, adopt some of the provisions of the FAIR MAPS Act as best practices when establishing ward boundary lines; a

reference to communities of interest<sup>1</sup>; and updated criteria language to clarify actions to be completed by the Ad Hoc Committee and meetings and hearings to be conducted by the full Board. If the Committee approves the draft guidelines, the guidelines will be presented to the Board for consideration at its September 14, 2021 meeting.

#### Public Use of Redistricting Software

Staff reviewed the licensing agreement for the District's redistricting software and determined the license does not provide for public use of the software. The District reviewed other mapping tools which would cost approximately \$50,000 not including staff time to implement and manage. Staff is currently reviewing free, open-source mapping tools to determine if one can be used by the public to submit map proposals and/or maps depicting communities of interest to the District for consideration. Staff will provide an update on mapping tools at the September 28, 2021 Redistricting Ad Hoc Committee meeting.

#### Special Districts and the FAIR MAPS Act

Based on legislative reports, there was opposition to extending the FAIR MAPS Act to special districts, school districts, community college districts and county boards of education. Opponents argued that including these local agencies in the Act would result in more redistricting meetings than the public could possibly attend, resulting in meetings being held simultaneously with city and county redistricting meetings. Opponents argued that local agencies and cities and counties would be competing for the public's participation and that local agencies would likely expend significant taxpayer dollars in employee overtime, rental space and equipment.<sup>2</sup> Following the committee hearing in which opponents raised these arguments, the FAIR MAPS Act was amended to apply only to cities and counties.

Accessibility for All Board Meetings (e.g., closed captioning in multiple languages during livestreamed meetings; real-time translation; real-time interpreters; materials translated into the common languages spoken in the service area)

Staff began using the closed captioning feature in Zoom during the August 10, 2021 Board meetings. Currently, the feature supports only the English language. To provide closed captioning in multiple languages in Zoom, the District would either need interpreters to participate in each Zoom meeting to provide translated audio or work with a third-party vendor to provide closed captioning in multiple languages in Zoom. If the District elected to have interpreters participate in its virtual meetings, meeting attendees would be able to select the audio channel to hear the translated audio in their language of choice.

To increase accessibility to Board meetings, staff is researching costs and technical requirements for third-party vendors that provide closed captioning for Zoom meetings in multiple languages. Staff will continue exploring ways to provide greater accessibility for non-English speakers to participate in Board meetings, including translating meeting materials into the common

languages spoken in the District's service area. Staff will update the Board on this information at a future meeting.

### Public Hearings for Redistricting (including if virtual meetings count as public meetings for the purposes of redistricting)

Virtual meetings of governing bodies are authorized by Governor Newsom's Executive Order N-08-2021, which suspends portions of the Brown Act which provide specific requirements for holding public meetings by webinar or teleconference. Thus, public hearings and meetings for redistricting that are conducted by webinar or teleconference count as public meetings for the purposes of redistricting. The executive order is set to expire on September 30, 2021, after which, all public meetings would be held according to the requirements of the Brown Act. Public hearings and meetings for redistricting may be held in a physical location where the Board of Directors would be physically present to consider the proposed boundaries and to take a vote on the final ward boundaries.

#### Redistricting Tab or Hyperlink on the District's Homepage

A hyperlink to the redistricting webpage will be available under the Announcements section on the ebmud.com homepage.

#### Census Data Status

In February 2021, the U.S. Census Bureau announced that due to COVID-19 pandemic related delays, redistricting data would not be released until September 30, 2021. On August 12, the Bureau announced it provided each state with population counts to use in their redrawing of congressional and state legislative district boundaries. The Bureau is scheduled to release the same data in "easier-to-use" formats by September 30. Staff reviewed the August 12 data and determined it can be used to begin redistricting efforts.

#### NEXT STEPS

Staff will discuss the proposed redistricting schedule at the August 24, 2021 Redistricting Ad Hoc Committee meeting. The Committee will review the draft redistricting guidelines and criteria to present to the Board for consideration at its September 14, 2021 meeting. Staff will also continue reviewing the online mapping tools; explore ways to increase accessibility for all Board meetings; and draft a redistricting web page with a soft launch scheduled for mid-September.

The next Redistricting Ad Hoc Committee meeting is scheduled for September 28, 2021.

#### EBMUD 2021-2022 Redistricting Guidelines and Criteria

The FAIR MAPS Act (AB 849) was enacted in 2019 and is intended to improve public engagement and communication regarding the process of redistricting for cities and counties. The EBMUD Board of Directors wishes to achieve the improved transparency and fairness provided for in the Act by, to the extent practicable, adopting some of its provisions as best practices. As such, the EBMUD Board of Directors intends to establish ward boundary lines in accordance with the following guidelines and criteria.

#### Guidelines

- To achieve as precise equality of population among wards as possible.
- Board members residences will be maintained within their current wards.
- City boundaries will be followed as closely as possible.
- Ethnic communities and/or communities of interest<sup>1</sup> will be kept whole as nearly as possible.
- County precincts will not be split.

#### Criteria

- Establish an ad hoc committee comprised of three board members appointed by the Board of Directors to hold public meetings regarding the District's redistricting options. At least one public meeting of the ad hoc committee shall be held East of hills<sup>2</sup> for public review and comment on options for redistricting plans. The ad hoc committee shall hold at least two public meetings prior to the first public hearing to be held by the Board of Directors to consider the proposal for redistricting.
- The ad hoc committee will propose options for redistricting plans, which reflect the total and eligible voting populations, racial and ethnic composition and maps delineating District, city and county boundaries, to the extent this information is available. Options for redistricting plans shall be made available to the public at least 14 days prior to the first public hearing held by the Board of Directors to consider the proposal for redistricting.
- Documentation of the proposed redistricting plan to be adopted by the Board shall be made available to the public at least 14 days prior to the scheduled public hearing on the vote on the ultimate redistricting configuration.
- No substantive amendments to the alternative plans or the proposed redistricting plan to be adopted by the Board may occur during the 14-day review period prior to the final vote on the ultimate redistricting configuration.
- The Board of Directors will hold at least one public hearing to consider the proposal for redistricting prior to taking action on the ultimate redistricting configuration and ward boundaries.
- The Board of Directors will hold at least one public hearing to take final action on the ultimate redistricting configuration and ward boundaries.



Section 11823 of the MUD Act requires the Board by resolution or ordinance to fix the boundaries of the wards for the purpose of electing directors. The EBMUD Board of Directors is authorized to adjust District ward boundaries every ten years based on data from the U.S. decennial census.

On May 11, 2021 the Board appointed a Redistricting Ad Hoc Committee

On June 22, 2021 the Ad Hoc Committee reviewed the redistricting guidelines and criteria used in 2011-2012 and provisions from the FAIR MAPS Act (AB 849 – Bonta) Recap of June 22, 2021 Meeting

Ad Hoc Committee directed staff to draft guidelines that reference the FAIR MAPS Act and address the following:

- Public use of District software to draft boundary maps
- Why special districts not included in FAIR MAPS Act
- Accessibility for all Board meetings including livestreamed redistricting meetings
- Public hearing requirements for redistricting
- Whether virtual meetings count as public meetings for the purposes of redistricting
- Adding redistricting information on District's homepage

# FAIR MAPS Act (AB 849)

- Enacted in 2019 by the CA legislature
- Intended to improve public engagement and communication in redistricting for cities and counties
- Amended Election Code provisions applicable to cities and counties; does not apply to the District
- The Ad Hoc Committee recommends the Board to the extent practicable, follow some provisions as best practices to achieve the improved transparency and fairness in the Act

# Draft Guidelines and Criteria

### Guidelines

- To achieve as precise equality of population among wards as possible
- Board members residences will be maintained within their current wards
- City boundaries will be followed as closely as possible
- Ethnic communities and/or communities of interest will be kept whole as nearly as possible
- County precincts will not be split

# Draft Guidelines and Criteria (cont)

### Criteria

- Establish an Ad Hoc Committee
- Hold public Ad Hoc Committee meetings with at least one meeting held East of hills
- At least two public Ad Hoc Committee meetings prior to the first Board public hearing to consider redistricting proposal
- Ad Hoc Committee propose alternative redistricting plans, with available population, racial, and ethnic data and District, city and county boundaries

# Draft Guidelines and Criteria (cont)

### **Criteria (continued)**

- Make redistricting plan options available to public at least 14 days prior to first public hearing
- Make proposed redistricting plan available to public at least 14 days prior to public hearing for Board final vote
- No substantive amendments to alternative plans or final plan during 14-day review period prior to Board final vote
- Board will hold at least one public hearing to consider redistricting plan options prior to taking final action
- Board will hold at least one public hearing to take final action

# 2020 Census Data

- In February 2021, the U.S. Census Bureau announced redistricting data would not be released until September 30, 2021.
- On August 12, the Bureau released data to states
- The Bureau is scheduled to release the same data in "easier-to-use" formats by September 30
- Staff reviewed the August 12 data and determined it can be used to begin redistricting efforts
