I. <u>STATEMENT OF WORK</u>

A. <u>SCOPE</u>

The project is intended to assess the vulnerability of and risks to the District's Information Technology (IT) environment. Specifically including the District's business and administration systems and excluding the Internal Control Systems. This would include: evaluating internal controls and operating procedures; determining whether adequate safeguards are in place to secure and maintain vigilance of District data, communications, and facilities; and establishing a baseline for the District's compliance with the Center for Internet Security's Critical Security Controls (CSC20).

Specifically the awardee will evaluate the procedures and conduct testing in the areas described below; develop recommendations for mitigating any risks or control weaknesses identified; and provide recommendation for implementing CSC20 controls:

- 1. Internal and external
- 2. Sensitive and critical applications
- 3. Network configuration
- 4. Data/traffic monitoring and detection
- 5. Security administration

B. <u>PROPOSER QUALIFICATIONS</u>

- 1. Proposer Minimum Qualifications
 - a. Proposer, Proposer's principal, or Proposer's staff shall have demonstrated the requisite experience, knowledge, and expertise to conduct a comprehensive vulnerability assessment and have knowledge of CSC20 controls and/or NIST 80053 standards.
 - b. Proposer shall possess all permits, licenses, and professional credentials necessary to perform services as specified under this RFP.

C. <u>SPECIFIC REQUIREMENTS</u>

Project Scope

To assess security of the District's Information Technology (IT) environment, evaluate internal controls and procedures, and ensure general safeguards are in place to secure and maintain vigilance of District data, communications, and facilities. Specifically, evaluate the procedures and conduct testing in the areas described below and develop recommendations for mitigating any risks or control weaknesses identified.

Internal and external access

Evaluate the adequacy of the controls over internal and external access points. The vendor will determine the level of exposure to threats by conducting penetration testing in order to identify and mitigate control weaknesses. This should also include conducting vulnerability scans to detect control weaknesses in the District's network, applications, systems, and facilities. The vendor should demonstrate experience and expertise utilizing various scanning products (Appscan, Nessus, Nipper, Rapid7, Retina, Qualys, etc.) in identifying actual or potential vulnerabilities and/or control weaknesses.

Sensitive and critical applications

Identify and assess all applications used to develop, process, or transmit critical, confidential, or sensitive information (i.e., critical applications), whether on or off the District's Network, for compliance with password configuration, change controls, and other protocols to ascertain any vulnerabilities.

Network configuration

Evaluate the District's network configuration (i.e., how server, router, firewall interfaces are established) to ensure servers that house critical applications are properly configured to ensure transmission and/or exchange of information is adequately secured, that integrity is maintained, and adequate safeguards are in place to prevent compromise. This should include development and review of a comprehensive network topology diagram with all interfaces and connections; an assessment of the appropriateness of network devices in relation to their intended use; and review of the physical accessibility which could result in exposure to unwarranted penetration, including use of IPads and laptops for remote access.

Data/traffic monitoring and detection

Assess the detective/monitoring controls that have been established to identify attempts to infiltrate the network devices and applications. Specifically, to evaluate scanning tools used by District staff to detect and restrict internal or external penetration attempts and the procedures employed to identify and address threats. This should include evaluating the follow up actions taken by staff to address issues that have been identified as a result of monitoring efforts (i.e., database security project "punch list").

Security administration

Review the District's IT security organizations, role in identifying, responding to and mitigating internal and external threats, confirm that it has clearly defined and properly established roles and responsibilities, and that sufficient security training and education to promote employee vigilance is conducted. Establish a baseline of compliance with CSC20 that can be used as a benchmark for progress in future assessments.

Methodology and Approach

Proposals should include:

- A description of the approach that will be used to conduct an assessment in each of the scope areas.
- A list of the staff that will be utilized to conduct the review and a description of the experience and background in the performing assessment in the areas identified.
- A description/list of the information and/or resources required from EBMUD in order to conduct the review.
- Project schedule including timelines for completing each of the scope areas and estimated number of hours to complete each area.
- Total project budget.

D. <u>DELIVERABLES / REPORTS</u>

A written report containing:

- 1. A summary description of the methodology and approach including the tools used to complete each of the listed elements of the project scope.
- 2. The results of tests performed and the conclusions reached based on the results.
- 3. A list of the potential risks, control weaknesses, or exposures identified during the review and recommendations for addressing each.
- 4. An overall assessment of the District's IT control environment including District compliance with National Institute of Standards and Technology (NIST) Critical Infrastructure Protection (CIP) standards.

III. DISTRICT PROCEDURES, TERMS, AND CONDITIONS

A. <u>RFP ACCEPTANCE AND AWARD</u>

- 1. RFP responses will be evaluated by the Selection Committee and will be scored and ranked in accordance with the RFP section entitled "Evaluation Criteria/Selection Committee."
- 2. The Selection Committee will recommend award to the Proposer who, in its opinion, has submitted the RFP response that best serves the overall interests of the District. Award may not necessarily be made to the Proposer with the lowest overall cost.
- 3. The District reserves the right to award to a single or to multiple General or Professional Service Providers, dependent upon what is in the best interest of the District.
- 4. The District has the right to decline to award this contract or any part of it for any reason.
- 5. Any specifications, terms, or conditions issued by the District, or those included in the Proposer's submission, in relation to this RFP, may be incorporated into any purchase order or contract that may be awarded as a result of this RFP.
- 6. Award of contract. The District reserves the right to reject any or all proposals, to accept one part of a proposal and reject the other, unless the bidder stipulates to the contrary, and to waive minor technical defects and administrative errors, as the interest of the District may require. Award will be made or proposals rejected by the District as soon as possible after bids have been opened.

B. <u>EVALUATION CRITERIA/SELECTION COMMITTEE</u>

All proposals will be evaluated by a Selection Committee. The Selection Committee may be composed of District staff and other parties that have expertise or experience in this type of procurement. The Selection Committee will select a Proposer in accordance with the evaluation criteria set forth in this RFP. The evaluation of the RFP responses shall be within the sole judgment and discretion of the Selection Committee.

The Selection Committee will evaluate each RFP response meeting the qualification requirements set forth in this RFP. Proposer should bear in mind that any RFP response that is unrealistic in terms of the technical or schedule commitments, or unrealistically high or low in cost, will be deemed reflective of an inherent lack of technical competence or indicative of a failure to comprehend the complexity and risk of the District's requirements as set forth in this RFP.

California Government Code Section 4552: In submitting an RFP response to a public purchasing body, the Proposer offers and agrees that if the RFP response is accepted, it will assign to the purchasing body all rights, title, and interest in and to all causes of action it may have under Section 4 of the Clayton Act (15 U.S.C. Sec. 15) or under the Cartwright Act (Chapter 2, commencing with Section 16700, of Part 2 of Division 7 of the Business and Professions Code), arising from purchases of goods, materials, or services by the Proposer for sale to the purchasing body pursuant to the RFP response. - 8. Proposer expressly acknowledges that it is aware that if a false claim is knowingly submitted (as the terms "claim" and "knowingly" are defined in the California False Claims Act, Cal. Gov. Code, §12650 et seq.), the District will be entitled to civil remedies set forth in the California False Claim Act.

CONTRACT EQUITY PROGRAM & EQUAL EMPLOYMENT OPPORTUNITY

EXHIBIT B INSURANCE REQUIREMENTS

Insurance certificates are not required at the time of submission; however, by signing Exhibit A – RFP Response Packet, the Proposer agrees to meet the minimum insurance requirements stated in the RFP. This documentation must be provided to the District, prior to award.

For any coverage that is provided on a claims-made coverage form (which type of form is permitted only where specified) the retroactive date must be shown and must be before the date of this Agreement, and before the beginning of any Services related to this Agreement.

The following are the minimum insurance limits, required by the District, to be held by the GENERAL OR PROFESSIONAL SERVICE PROVIDER performing on this RFP:

INSURANCE

A. <u>Insurance Requirements</u>

GENERAL OR PROFESSIONAL SERVICE PROVIDER shall take out and maintain during the life of the Agreement <u>Workers Compensation Insurance</u> for all of its employees on the project. In lieu of evidence of Workers Compensation Insurance, the District will accept a Self-Insured Certificate from the State of California. GENERAL OR PROFESSIONAL SERVICE PROVIDER shall require any subcontractor to provide it with evidence of Workers Compensation Insurance.

Waiver of Subrogation. Workers' Compensation insurance must contain a waiver of subrogation endorsement providing that each insurer waives any rights of recovery by subrogation, or

otherwise, against the DISTRICT, its directors, officers, officials, agents, volunteers, and employees. CONSULTANT shall defend and pay any damages as a result of failure to provide the waiver of subrogation from the insurance carrier.

C. <u>Professional Liability Insurance (Errors and Omissions)</u>

GENERAL OR PROFESSIONAL SERVICE PROVIDER shall maintain during the life of the agreement professional liability insurance with a minimum of \$2,000,000/Occurrence. A three year tail is required if coverage on a claims-made basis. A deductible may be acceptable upon approval by the District. The policy will provide 30 days advance written notice to the District for cancellation or reduction in coverage. The Consultant shall require any subcontractor to provide evidence of the same professional liability insurance coverage.

D. Cyber Liability Insurance

Cyber Liability Insurance, with limits not less than \$2,000,000 per occurrence or claim, \$2,000,000 aggregate. Coverage shall be sufficiently broad to respond to the duties and obligations as is undertaken by GENERAL OR PROFESSIONAL SERVICE PROVIDER in this agreement and shall include, but not be limited to, claims involving infringement of intellectual property, including but not limited to infringement of copyright, trademark, trade dress, invasion of privacy violations, information theft, damage to or destruction of electronic information, release of private information, alteration of electronic information, extortion and network security. The policy shall provide coverage for breach response costs as well as regulatory fines and penalties as well as credit monitoring expenses with limits sufficient to respond to these obligations.

If Coverage is written on a claims-made form, the following shall apply:

1. The retroactive date must be shown, and must be before the date of the Agreement or the beginning of the Services.

2. Insurance must be maintained and evidence of insurance must be provided for a minimum of three (3) years after completion of the Services.

3. If claims-made coverage is canceled or non-renewed, and not replaced with another claimsmade policies form with a retroactive date prior to the effective date of the Agreement, CONTRACTOR must purchase an extended period of coverage for a minimum of three (3) years after completion of the Services.

E. Technology Errors and Omissions Liability (aka Technology Professional Liability).

- A. Limits of not less than \$2,000,000 per occurrence or claim, with a \$2,000,000 aggregate. Coverage shall be broad enough to respond to the duties and obligations to be undertaken by Contractor under this agreement, and shall include, but not be limited to the following coverages:
 - i. Theft, dissemination and/or use of confidential or personally identifiable information (PII), including breach response costs, credit monitoring and regulatory fines and penalties from such theft, dissemination or use of the confidential information;
 - ii. Network security liability arising from the unauthorized use of access to, or tampering with computer systems;
 - iii. Liability arising from the failure of technology products (software) required under the contract for Contractor to properly perform the services intended;
 - iv. Electronic Media Liability arising from personal injury, plagiarism or misappropriation of ideas, domain name infringement or improper deep-linking or framing, and infringement or violation of intellectual property rights;
 - v. Liability arising from the failure to render professional services.

If Coverage is written on a claims-made form, the following shall apply:

1. The retroactive date must be shown, and must be before the date of the Agreement or the beginning of the Services.

2. Insurance must be maintained and evidence of insurance must be provided for a minimum of three (3) years after completion of the Services.

3. If claims-made coverage is canceled or non-renewed, and not replaced with another claimsmade policies form with a retroactive date prior to the effective date of the Agreement, CONTRACTOR must purchase an extended period of coverage for a minimum of three (3) years after completion of the Services.

F. Commercial General Liability Insurance

GENERAL OR PROFESSIONAL SERVICE PROVIDER shall take out and maintain during the life of the Agreement <u>Automobile and General Liability Insurance</u> that provides protection from claims which may arise from operations or performance under this Agreement. If GENERAL OR PROFESSIONAL SERVICE PROVIDER elects to self-insure (self-fund) any liability exposure during the contract period above \$50,000, GENERAL OR PROFESSIONAL SERVICE PROVIDER is required to notify the District immediately. Any request to self-insure must first be approved by the District before the changed terms are accepted. GENERAL OR PROFESSIONAL SERVICE PROVIDER shall require any subcontractor or Professional Service Provider to provide evidence of liability insurance coverages.

The amounts of insurance shall be not less than the following:

\$2,000,000/Occurrence, Bodily Injury, Property Damage -- Automobile. \$2,000,000/Occurrence, Bodily Injury, Property Damage -- General Liability. The following coverages or endorsements must be included in the policy(ies):

- 10. The policy(ies) and/or a separate pollution liability policy(ies) shall cover pollution liability for claims related to the release or the threatened release of pollutants into the environment arising out of or resulting from Consultant's performance under this agreement.
- 11. The policy(ies) will not be canceled nor the above coverages/endorsements reduced without 30 days written notice to East Bay Municipal Utility District at the address above.

I. <u>WITNESSETH</u>

WHEREAS, CONSULTANT represents that it has the experience, qualifications, staff expertise, and where necessary, the required Department of Industrial Relations (DIR) registration to perform said services in a professional and competent manner;

NOW, THEREFORE, it is mutually agreed by DISTRICT and CONSULTANT as follows:

- 1. <u>Scope of Services</u>. CONSULTANT agrees to furnish services as set forth in the Scope of Services attached hereto as Exhibit "A" and incorporated herein. The work to be performed pursuant to this Agreement shall be completed as outlined in the project schedule.
- 2. <u>Compensation</u>. DISTRICT agrees to pay CONSULTANT for services under this Agreement according to the rates in attached Exhibit "B" and incorporated herein, provided that total costs shall not exceed the Agreement Ceiling of \$(*dollars*). CONSULTANT certifies that the proposed rates reflect the payment of prevailing wage rates where applicable.
- 3. <u>Commencement of Work</u>. This Agreement shall become effective upon execution of the second signature. CONSULTANT shall commence work upon receipt of DISTRICT's Notice to Proceed, which shall be in the form of a letter signed by DISTRICT's Project Manager. DISTRICT's Notice to Proceed will specify which tasks and/or optional services of the Scope of Services described in Exhibit "A" are authorized with ceiling prices within the Agreement Ceiling in paragraph 2 above. No work shall commence until the Notice to Proceed is issued.
- 4. <u>Billing and Payment</u>. CONSULTANT shall invoice DISTRICT monthly for services rendered, setting forth a description of the costs incurred, the services performed, the date the services were performed, the amount of time spent on each date services were performed and by whom. CONSULTANT shall also provide any information which will assist DISTRICT in performing any audit of the invoices. CONSULTANT acknowledges that construction work on public works projects requires DIR registration and is subject to prevailing wage rates and includes work performed during the design and preconstruction phases of construction including, but not limited to, inspection and land surveying work. DISTRICT will pay CONSULTANT within thirty (30) days after receipt of a proper CONSULTANT invoice. CONSULTANT agrees to use every appropriate method to contain its fees and costs under this Agreement.
- 5. <u>Termination</u>. This Agreement may be terminated by DISTRICT immediately for cause or upon 10 days written notice, without cause, during the performance of the work.

If this Agreement is terminated CONSULTANT shall be entitled to compensation for services satisfactorily performed to the effective date of termination; provided, however, that DISTRICT may condition payment of such compensation upon CONSULTANT's delivery to DISTRICT of any and all documents, data, designs, drawings, report, manuals, photographs, computer software, videotapes, and other materials provided to or prepared by CONSULTANT in connection with this Agreement. Payment by DISTRICT for the services satisfactorily performed to the effective date of termination shall be the sole and exclusive remedy to which CONSULTANT is entitled in the event of termination and CONSULTANT shall be entitled to no other compensation or damages including, but not limited to, loss of anticipated profits, and expressly waives the same. Termination under this Paragraph 5 shall not relieve CONSULTANT of any warranty obligations or the obligations under Paragraphs 6 and 10.

- 6. <u>Release of Information</u>. CONSULTANT agrees to maintain in confidence and not disclose to any person or entity without DISTRICT's prior written consent, any trade secret or confidential information, knowledge or data relating to the products, process, or operation of DISTRICT. CONSULTANT further agrees to maintain in confidence and not to disclose to any person or entity any data, information, technology, or material developed or obtained by CONSULTANT during the term of this Agreement. The covenants contained in this paragraph shall survive the termination of this Agreement for whatever cause.
- 7. <u>Ownership of Materials Prepared</u>. The originals of all computations, drawings, designs, graphics, studies, reports, manuals, photographs, videotapes, data, computer files, and other documents prepared or caused to be prepared by CONSULTANT or its subconsultants in connection with these services shall be delivered to and shall become the exclusive property of DISTRICT. DISTRICT is licensed to utilize these documents for DISTRICT applications on other projects or extensions of this project, at its own risk. CONSULTANT and its subconsultants may retain and use copies of such documents, with written approval of DISTRICT.
- 8. <u>Designation of Consulting Personnel</u>. CONSULTANT agrees that all services under this Agreement shall be performed under the direction of (*Consultant Project Manager's name*). Any change of personnel by CONSULTANT shall have DISTRICT approval. DISTRICT contact throughout the period of this Agreement shall be (*District Project Manager's name*), Project Manager.

9. <u>Independent Contractor and Professional Responsibility of Consultant.</u>

a. b. It is further understood and agreed by the parties hereto that CONSULTANT in the performance of its obligations hereunder is subject to the control or direction of DISTRICT as to the designation of tasks to be performed, the results to be accomplished by the services hereunder agreed to be rendered and performed, and not the means, methods, or sequence used by the CONSULTANT for accomplishing the results. c. If, in the performance of this agreement, any third persons are employed by CONSULTANT, such person shall be entirely and exclusively under the direction, supervision, and control of CONSULTANT. All terms of employment, including hours, wages, working conditions, discipline, hiring, and discharging, or any other terms of employment or requirements of law, shall be determined by CONSULTANT, and DISTRICT shall have no right or authority over such persons or the terms of such employment.

d. It is further understood and agreed that as an independent contractor and not an employee of DISTRICT, neither the CONSULTANT nor CONSULTANT's assigned personnel shall have any entitlement as a DISTRICT employee, right to act on behalf of DISTRICT in any capacity whatsoever as agent, nor to bind DISTRICT to any obligation whatsoever. CONSULTANT shall not be covered by DISTRICT's worker's compensation insurance; nor shall CONSULTANT be entitled to compensated sick leave, vacation leave, retirement entitlement, participation in group health, dental, life or other insurance programs, or entitled to other fringe benefits payable by DISTRICT to employees of DISTRICT.

10. Indemnification

CONSULTANT expressly agrees to defend, indemnify, and hold harmless DISTRICT and its Directors, officers, agents and employees from and against any and all loss, liability, expense, claims, suits, and damages, including attorneys' fees, arising out of or pertaining or relating to CONSULTANT's, its associates', employees', subconsultants', or other agents' negligence, recklessness, or willful misconduct, in the operation and/or performance under this Agreement.

- 11. <u>Time of the Essence</u>. CONSULTANT agrees to diligently perform the services to be provided under this Agreement in accordance with the schedule specified herein. In the performance of this Agreement, time is of the essence.
- 12. <u>Notice</u>. Any notice or communication given under this Agreement shall be effective when deposited postage prepaid with the United States Postal Service and addressed to the contracting parties as follows:
