**Project Description:** The East Bay Municipal Utility District (EBMUD) Main Wastewater Treatment Plant (MWWTP) Land Use Master Plan EIR (LUMP EIR) was prepared and certified in 2011 to serve as a high-level planning tool to guide development of the existing 48-acre MWWTP site and the newly-acquired, adjacent 15.9-acre West End property (former U.S. Army Reserve Center) over a 30-year time horizon. The LUMP EIR identified two renewable energy projects for implementation in the near future—biodiesel production and food waste preprocessing—to help EBMUD meet sustainability goals by increasing on-site power generation. Those two projects did not move forward as described in the LUMP EIR, and EBMUD has now replaced the food waste project with a hydrogen refueling station (HRS) to fuel heavy-duty fuel cell trucks serving the Port of Oakland. The HRS would involve deliveries of liquid cryogenic hydrogen and a cryogenic fueling system on an equipment skid that includes liquid hydrogen storage, cryogenic pump, pressurized hydrogen storage, and mechanical and electrical facilities within a containerized enclosure. In addition, there would be up to two hydrogen dispenser pumps covered by canopies, and a new PG&E electrical connection with transformer and meter on a pedestal. The project may be expanded to include a second storage system and canopy with two additional hydrogen dispenser pumps. A proposed site layout is included as Attachment 1. The HRS is expected to be constructed in two phases, the first taking approximately three months, and would involve demolition of an existing building, excavation to install foundations and driveways, construction of concrete rebar-reinforced pads for equipment and dispenser areas, trenching for utility lines, and installation of equipment.

May 25, 2021 and has made the following determinations regarding the above described project.

1. EBMUD certified the LUMP EIR in 2011 and completed an Addendum to the LUMP EIR in May 2021 to replace the food waste preprocessing project with the HRS project and analyze the environmental effects of that project.
2. The modifications do not involve significant new environmental effects not analyzed in the LUMP EIR, nor do they substantially increase the severity of significant effects previously identified in the LUMP EIR, nor has new information of substantial importance arisen since the LUMP EIR was certified. Therefore, the HRS project described in the Addendum will not result in a significant effect on the environment.
3. EBMUD adopted the mitigation measures and the mitigation monitoring or reporting program (MMRP) identified in the LUMP EIR at the time it certified that document. The Addendum did not change the mitigation measures or the MMRP. As described in the Addendum, the HRS project will comply with mitigation measures and the MMRP as applicable.
4. Findings and a Statement of Overriding Considerations were adopted for the LUMP EIR but were not adopted for the HRS project because the modifications do not involve significant new environmental effects not analyzed in the LUMP EIR nor do they substantially increase the severity of significant effects previously identified in the LUMP EIR.

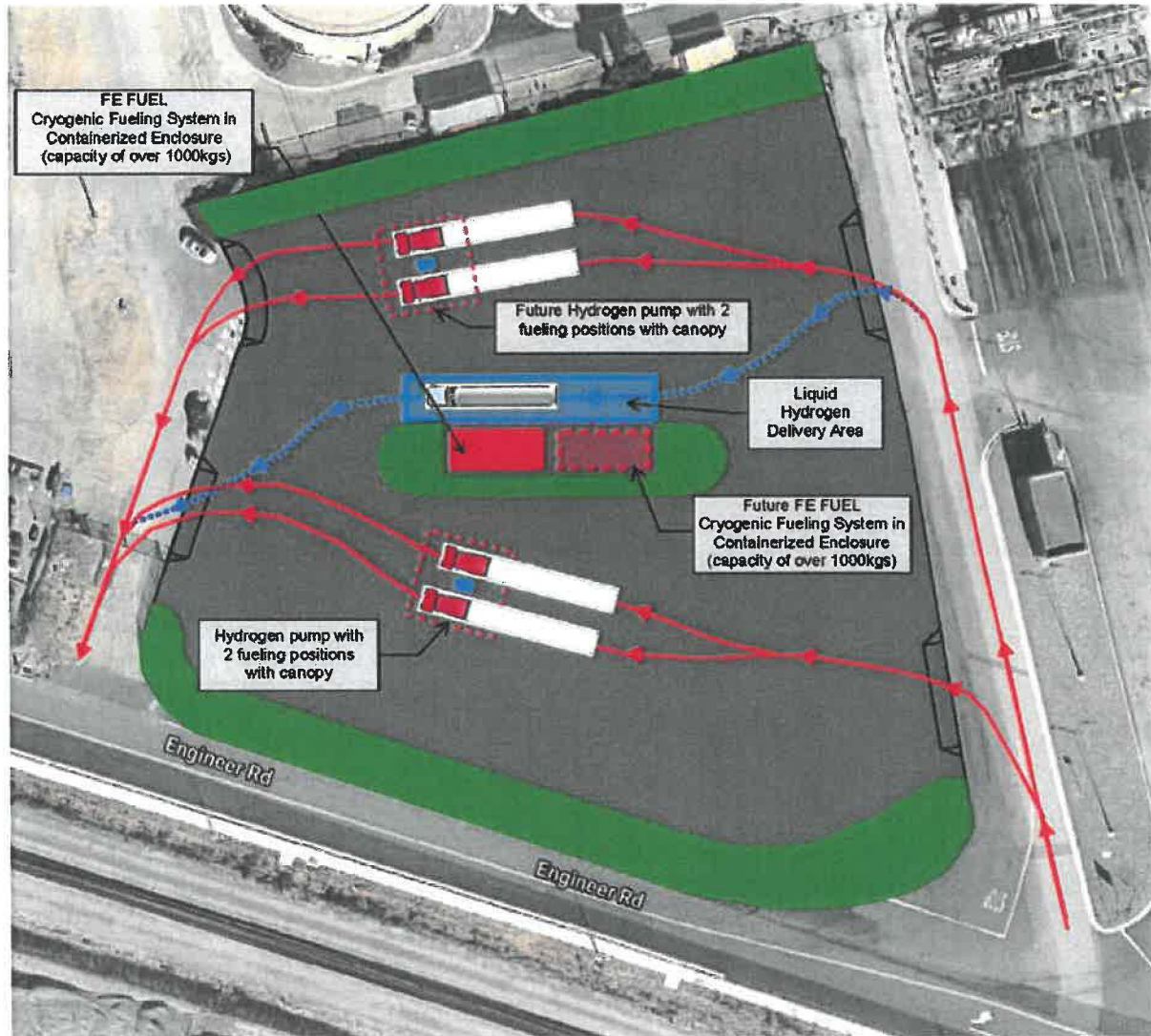

**Project Description:** The EBMUD Main Wastewater Treatment Plant (MWWTP) Land Use Master Plan (Master Plan) has been prepared to serve as a high-level planning tool to guide development of the existing 48-acre MWWTP site and the newly-acquired, adjacent 15.9-acre West End property (former U.S. Army Reserve Center) over a 30-year time horizon. The MWWTP is located at 2020 Wake Avenue, Oakland, CA. The Master Plan coordinates near-term land uses with potential plans for future expansion to maintain an efficient plant layout and minimize building demolition and facility relocation requirements. Short- and long-term layouts were developed with recommended locations for identified projects given available land at the MWWTP, which now includes the West End property.

EBMUD has identified short- and long-term actions that may be implemented at the MWWTP in the future. Many of the potential actions would not be undertaken until the facilities are needed to meet a specific future regulatory requirement. The purpose of this EIR is to evaluate the range of potential projects that could be developed as part of the Master Plan. In particular, two renewable energy projects have been identified and are being considered for implementation in the near future—biodiesel production and food waste preprocessing—to help EBMUD meet sustainability goals by increasing on-site power generation. Both projects involve contracting with private companies under a land-lease agreement to construct and operate a facility at the MWWTP.
