DERWA Overview



- Dublin San Ramon Services District – East Bay Municipal Utility District Recycled Water Authority formed in 1995
- Provides recycled water for landscape irrigation to customers in San Ramon, Danville, Dublin and Pleasanton
- Multiple agreements are currently in place

Pause Period



- 3-Year Pause with Side Agreement
 - Demands anticipated to remain flat
 - Operational experience with CCCSD flow diversion
- Negotiation to update JPA to restart in beginning of Year 3
 - Final revisions completed by end of Year 3

Actions During Pause Period




- Monitor Regulations (WW discharge/ nutrients and potable reuse)
- Monitor key supply efforts and decisions
- Implement Demand Management Strategies
- Review WW flow trends
- Track CCCSD's water recycling initiatives

Side Agreement Key Components

- Continue Connection Moratorium
- Implement Demand Management
- Address Recycled Water Shortages
- No Charge for Secondary Effluent
- Pursue Supplemental Supplies
- Tri-Valley Joint Residential Fill Station Impacts
- No Changes to JPA Membership Structure
- Establish Principles for Future Agreement Negotiations

Project Overview




- Horizontal Direction Drill (HDD) Crossing
 - 3,000 ft. of 32" HDPE under the Oakland Inner Harbor
 - Pipeline laydown along Marina Village Pkwy.
- Open Trench
 - 3,500 ft. of 24" pipe in Oakland
 - 6,400 ft. of 24" pipe in Alameda
- Abandon Existing Crossing
- Construction Cost \$32 to \$34M






Oakland HDD Staging Area






Alameda HDD Staging Area





Crossing Pipeline Laydown






DETAIL A - PIPE STRING WORKSPACE


Approach Pipeline - Oakland

 - Coordinated traffic control, paving restoration, and easements



Emergency Planning



- · 22 Business Continuity Plans (BCPs)
 - Updated every two years; 9 updated in FY21
 - Exercised annually; 22 exercises in FY21
- · 29 Site Security Emergency Action Plans (SSEAPs)
 - Updated every five years or as needed
 - 16 updated in FY21
- Emergency Operations Plan (EOP)
 - Updated every five years or as needed

Mutual Aid Partnerships



- Continue agreement with Los Angeles Department of Water and Power (LADWP) and Las Vegas Valley Water District (LVVWD)
- Monthly meetings via videoconference
- LADWP and LVVWP attended the District's October 2020 EOT exercise
- May 2021 meeting with LADWP, LVVWD, Contra Costa Water District, and Denver Water

America's Water Infrastructure Act (AWIA)



- Federal law (2018) regulates utility emergency preparedness
- Risk and Resilience Assessment Completed March 2020
- Emergency Operations Plan Updated September 30, 2020
- · All AWIA requirements completed.

Earthquake Preparedness



- Earthquake Mitigation and Response Plan – Annex to the EOP
 - Substantial progress on updates to the plan in FY21
 - Complete update by 12/31/22


Regulatory Compliance Office

The District's Emergency Operations Plan (EOP) and associated documents contain sensitive information that has restrictions on its use. Distribution (in whole or part) must follow District Procedure 312.

When the District is responding to an emergency incident, the EOP can be released to outside official entities within the unified command structure. The Emergency Operations Director can direct the release of the EOP to outside official entities at any time.

Public Safety Power Shutoffs





- Portable generators deployed at critical pumping plants
- Long-term contract for additional rental generators
 - Procuring generators to reduce reliance on rental units
- Two PSPS events in FY21
 - October 14, 2021 9 District facilities affected, 1 generator put into service
 - October 25, 2021 84 District facilities affected, 21 generators put into service

COVID-19 Pandemic Response



- Emergency Operations Team (EOT) activated March 2020
- RSP 5800 COVID-19 Prevention Plan
- · COVID Hotline
- Testing Program
- Vaccination Policy
- Safe Return to Work Plan

- Continue EOT activation to manage COVID -19
- Complete update to Earthquake Mitigation and Response Plan
- Conduct EOT Functional Exercise
- Update BCPs and conduct exercises
- Conduct exercises and meetings with mutual assistance partners and stakeholders
