



Water Broom Rebate Program

Up to \$150

Program Eligibility Rules

EBMUD is offering a rebate of 50% (up to \$150) for the costs of a qualifying product, whichever is less, for each water broom purchased and used by customers within the EBMUD service area.

- This program applies to a water broom purchased between January 1, 2018 and December 31, 2018.
- This program is only for commercial accounts (i.e., non-residential customers).
- Water brooms must meet a minimum level of water efficiency to be eligible (see efficiency requirement below).
- The rebate will only be given to those customers that previously used a garden hose, hose and nozzle, power washer, or any other water using device for outdoor cleaning.
- Original receipt(s) must be submitted with the rebate application within 90 days of purchase and include the model number.
- Rebates are issued in the form of a credit applied to the EBMUD water service account and may take up to 6 weeks to process.
- Incomplete applications and those lacking original purchase receipts will be denied.
- Any site requesting a rebate may be subject to inspection by EBMUD staff.

Use the form on the back to apply for the rebate. The water broom rebate application must be received within 90 days of purchase.

Water Efficiency Requirements

Only products that use less than or equal to 0.10 gallons per minute (GPM) per linear inch of spray area will be approved.

For example, if the spray area of a water broom is 21", the maximum allowable gallon per minute consumption can be no more than 2.10 GPM. To perform this calculation:

$$\frac{\text{Manufacturer Rated (GPM)}}{\text{Broom Width (inches)}} = \text{Max GPM per linear inch } (\leq 0.10)$$

How to Receive a Rebate

1. Purchase a water boom within the qualifying rebate period.
2. Fill out the application on the back. All information must be entered.
3. Return the completed application and original, legible purchase receipt to:
