## ADDENDUM No.1 – May 7, 2015

Receipt of this Addendum must be acknowledged in Exhibit A of the RFP, which shall be submitted by CONTRACTOR as part of its bid.

- 1. Procurement and selection schedule has been revised (see cover page and page 19 for updates):
  - a. RFP responses are due by Thursday, May 28, 2015 at 4:00 p.m. PDT.
  - b. The anticipated award date is July 28, 2015.
  - c. The anticipated contract start date is August 2015.
- 2. Section I.E has been added (see page 18 for update):
  - a. The following paragraphs have been added:

"Each bid item will have a separate roster. The roster will be made up of CONTRACTORS who meet minimum qualifications; CONTRACTORS will be ranked by cost.

When work is available, EBMUD will notify the highest ranked bidder on the roster within the appropriate investigative methodology of the availability of the work, including the quantity of work to be performed and the anticipated schedule. Please note, the specific location of the work will not be disclosed, though EBMUD will attempt to aggregate work into concentrated areas. The contacted CONTRACTOR will have 48hours to respond via email stating their availability to undertake the work or portion of work. If a CONTRACTOR waives participation in a given work request, they will not be disgualified from future work efforts. In the event that a CONTRACTOR either waives a work request or does not respond, EBMUD will go to the next highest ranked bidder, who will have 48-hours to respond via email stating their availability to undertake the work. This process will repeat until all of the work requested has been accepted by CONTRACTOR(s) or all CONTRACTORS have been notified. Once all of the work has been claimed, EBMUD will then, if necessary, segment the work to match the quantities claimed per CONTRACTOR into separate work efforts and will notify the CONTRACTOR(s) of their specific work locations. Failure to meet an agreed-upon schedule after accepting work will disqualify the CONTRACTOR from future consideration."

- 3. Bid Item 7-Smoke Testing scope has been modified (see page 12 for updates):
  - a. Two public notifications are required;
  - b. CONTRACTOR shall use standardized notice created by EBMUD;
  - c. In addition to notifying fire and police department, CONTRACTOR shall also notify EBMUD and Satellites of work schedule. Satellite agency contact information shall be provided by EBMUD.

- 4. Bid Items 4, 5, 6, and 8 (see page A.6 for updates)
  - a. Costs associated with mobilization and demobilization shall be included in installation cost.
- 5. Bid Items 3, 9, 13, and 14 (see pages 7, 14, 17, and 18 for updates)
  - a. The following statement has been added: "Due to California's current drought crisis, potable water shall not be used for any non-potable purpose. EBMUD provides recycled water at no charge. Recycled water for trucks is available at EBMUD's main wastewater treatment plant in West Oakland and in North Richmond. Information on specific program requirements can be found on our website at <a href="http://www.ebmud.com/water-and-wastewater/recycled-water/recycled-water-truck-program">http://www.ebmud.com/water-and-wastewater/recycled-water/recycled-water-truck-program</a>."
- 6. Bid Item 13 Focused Electrode Leak Locator Test (see page 17 for updates):
  - a. The third sentence in the first paragraph has been modified to: "FELL testing shall have capabilities of performing test on all <u>non-conductive</u> pipe materials."
  - b. The last sentence in the first paragraph has been modified to: "FELL testing shall have capabilities of detecting defects anywhere along the pipe circumference. CONTRACTOR is responsible to ensure appropriate field conditions to meet this requirement."
- 7. Costs associated with payment bonds will be reimbursed by EBMUD
  - a. Section III.C (page 22) and Exhibit A-Proposal Form (page A.5) have been modified.
- 8. Exhibit A-Proposer Information and Acceptance
  - a. Item 10 on Page A.3 has been modified to clarify a 5% bid preference will be given to SBEs.
- 9. Exhibit C-General Requirements been added to the RFP.
