



EBMUD Wastewater Discharge Permit Application for Cannabis Businesses

Thank you for your time to complete a wastewater discharge application. This application is critical to determining the appropriate permit type for your business. Please note: once a completed application is received by EBMUD, the permit processing time is 3-4 weeks. As you complete this application, please be sure to include responses to all items listed in the general section as well as all that apply for either cultivation or manufacturing:

General:

- Number of employees, and hours of operation
- Provide a scaled building site plan and facility layout which must include each side sewer (point of discharge from building to sanitary sewer main), see Appendix A for example
- Include a process flow diagram and add estimated water consumption for each process, See Appendix B for example
- Provide a summary of the categories of products and services to be offered by business
- Provide estimated water consumption and wastewater discharge using the water balance table provided with this application
- If planning to expand the business in future, please also include a description and site plan (if applicable) of the proposed future expansion with this application

Cultivation:

- Provide total square footage of plant canopy
- Provide a description of the operation including cultivation technique
- Provide a list of all chemicals, including fertilizers and pesticides, and their representative safety data sheets used for cultivation

Manufacturing - Extraction:

- Describe the equipment and/or process used for cannabinoid extraction
- Provide a list of all chemicals and their representative safety data sheets used for extraction

Manufacturing – Edible:

- Please include proposed grease control device and representative product specification sheet

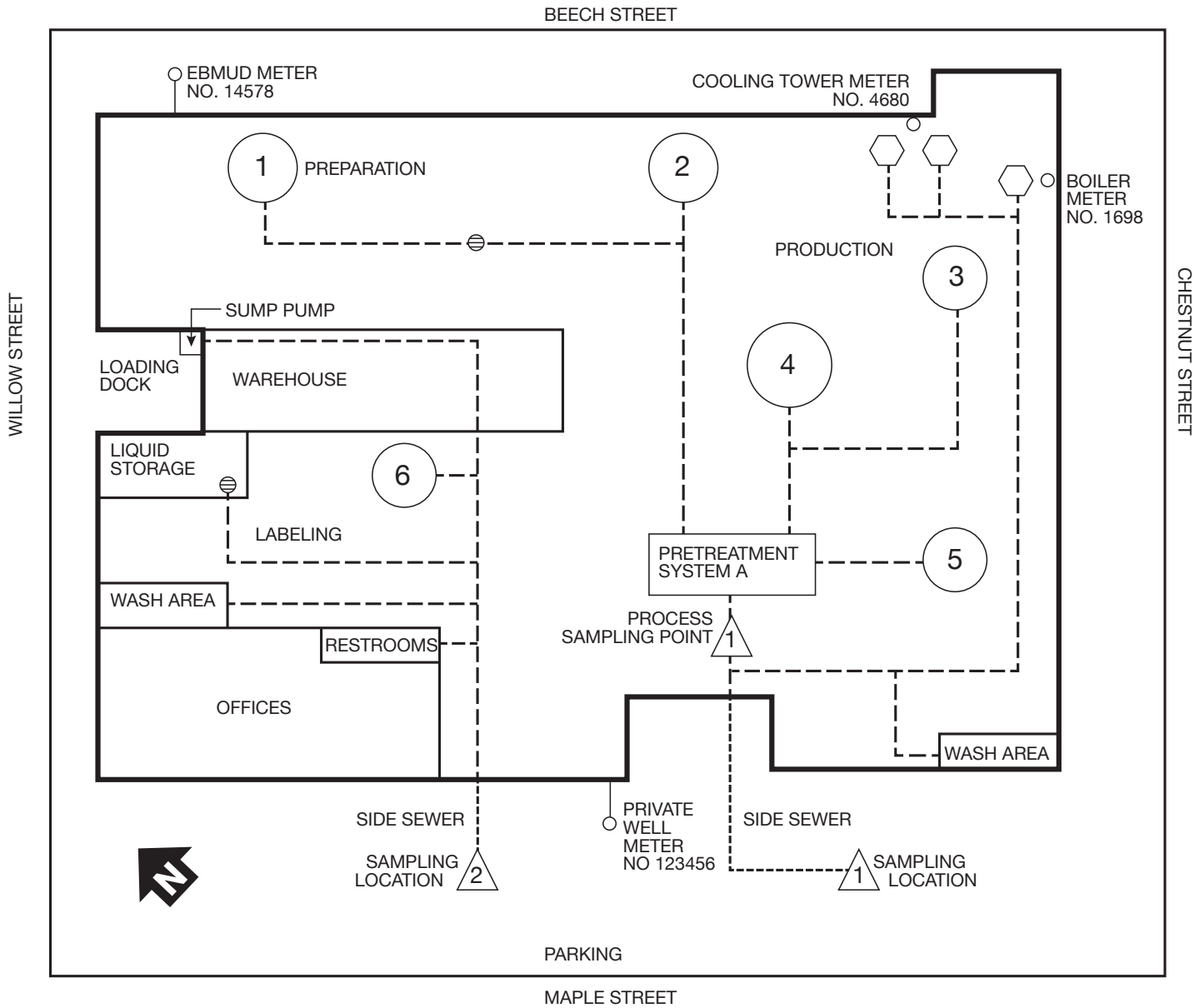
