Resolution in Response to Racial Discrimination and Violence Against Black and African Americans

Small Business Enterprises (SBE) Incentives

- Provides a seven percent bid discount up to a maximum of \$150,000 on competitive bid contract opportunities
- Allows set-aside for SBEs on contract awards of \$80,000 or less

Local Hire Goal

- Commits to a local workforce goal of 50 percent on construction projects over \$500,000

Customer Assistance Program (CAP)

Water Lifeline Program

COVID-19 Business-Related Updates

Funding Remains for SBA Economic Injury Disaster Loan Program

The Small Business Administration (SBA) reopened the Economic Injury Disaster Loan (EIDL) and EIDL Advance program portal to all eligible applicants experiencing economic impacts due to COVID-19. Additional small businesses and non-profits are able to receive long-term, low-interest loans and emergency grants – reducing the economic impacts of COVID-19 on their businesses, employees and the communities they support.

The deadline for applying has been extended to August 3, 2020.

- Apply online at SBA’s Disaster Loan Assistance Portal (<https://covid19relief.sba.gov>)
- Be sure to check the box at end of the application for up to \$10,000 advance grant, grant total is based on the pre-disaster employee count (\$1,000 per employee)

Business Reopening Guidance

New Occupational Safety and Health Administration (OSHA) guidance to help employers reopening non-essential businesses and their employees stay safe during the evolving COVID-19 pandemic contains recommendations as well as descriptions of mandatory safety and health standards. The recommendations are advisory in nature, informational in content, and are intended to assist employers in providing a safe and healthful workplace. Mokelumne Hatchery Residences Siding Replacement

Replace wooden siding on the residences of the Mokelumne River Hatchery complex with ship-lap style concrete siding. Project will include the disturbance, transport, and disposal of materials with lead-containing paint.

Main Wastewater Treatment Plant Paving Rehabilitation - SD-418

Sawcut, remove, dispose, and repave approximately 12,000 sq. ft. of existing asphalt paving and aggregate base. Replace approximately 30 ft. of sidewalk, curb, and gutter and 300 sq. ft. of reinforced concrete paving.

Main Wastewater Treatment Plant Process Piping Replacement - SD-426

Replace mechanical process piping in the pipe galleries and buildings, including gas piping to the power generation station and digested sludge piping.
