EBMUD offers higher Small Business Bid Discount for the New Year!

The state legislature recently enacted changes to California Code Public Contract Code Section 2002, which governs the authority of a local agency to provide bid discounts to small business enterprises (SBE), to increase the maximum discount from five to seven percent. In accordance, EBMUD's Board of Director also increased the bid discount from five to seven percent effective immediately. To receive the bid discount, the SBE must be deemed a responsive, responsible bidder.

The statute also places a mandatory cap on the amount of discount allowed per contract at \$150,000. The District's discount is currently set at \$250,000 per contract. To be consistent with the new law, the District's discount has been lowered to the statutorily mandated amount of \$150,000 per contract with a cumulative District cap at \$500,000.



As of January 1, 2019, California Government Codes 14837 and 14838 were amended to expand public works in the public arena. The amendments increase the maximum SBE three-year average gross annual receipts (GARs) eligibility from \$15 million to \$36 million, and increase the maximum number of employees from 100 to 200. The Public Contract Code Section 4525 defines a public works contract as an agreement for the erection, construction, alternation, repair, or improvement of any public structure, building, road, or other public improvement of any kind. The maximum SBE three-year average GAR for non-public works contracts remains \$15 million and 100 or fewer employees.

Take advantage of this new definition of a small business for Public Works (SB-PW) by getting certified by the State of California Office of Small Business and Disabled Veteran Business Enterprise Services (OSDS). All public works contractors SHOULD get certified by the state.
