## Contract Equity Program SBE Component Overview



#### SBE component currently includes:

- A goal of awarding fifty percent (50%) of all annual contracts < \$80,000 to SBEs;</li>
- A set aside of at least 25% of all annual contracts < \$80,000 for SBEs excluding purchases made with purchase cards;
- A 5% bid discount (not to exceed \$250,000 per contract) for responsive/responsible SBEs; and
- Disabled Veteran Business Enterprises

# SBE Bid Discount - Five Year Financial Impact (FY14-FY18)

### Legislative Changes



- SB 605 (effective January 1, 2019)
  - o Increases SBE three-year average annual gross receipts eligibility threshold from \$15 million to \$36 million for certified public works contractors working on a public works project and increases the maximum number of employees from 100 to 200

### Legislative Changes



- SB 605 (effective January 1, 2019) continued
  - Maintains current SBE eligibility threshold for non-public works contracts/projects at three-year average annual gross receipts of \$15 million and a maximum of 100 employees
  - Allows dollar thresholds to be adjusted to reflect changes in the California Consumer Price Index biennially

## SBE – Related Legislative Changes Cont.



- AB 2762 (effective January 1, 2019)
  - Increased allowable bid discount from five percent to seven percent
  - Established a cap of \$150,000 on the amount of the discount per contract

#### Recommendations



- Revised the Contract Equity (CE) Program SBE Component immediately to:
  - Increase SBE bid discount from five to seven percent
  - Reduce the maximum dollar amount for the SBE bid discount from \$250,000 to \$150,000 per contract
- Maintain the current threshold of \$500,000 for the total amount of bid discounts granted in a fiscal year
